Judging Contest Rules:

1. All contestants must be either a 4-H or FFA member.
2. A team may consist of three to four members to be eligible for team awards.
3. **Juniors** are from ages 8 to 13 years old, **Seniors / FFA Members** are from ages 14-18 years old.
4. **Absolutely NO CELL PHONES will be permitted during the contest and will result in disqualification.**

Judging Contest Process:

1. Ten classes consisting of four horses in each class will be judged. There shall be 3 halter classes and 7 performance classes.
 - a. The halter classes will consist of mares and geldings.
 - b. The performance classes will be selected from western pleasure, horsemanship, reining, ranch riding, hunter under saddle, hunt seat equitation, trail, hunter hack, and western riding.

Following the judging portion of the contest, lunch will be provided in the 4-H Dining Hall. There, the contestants will eat and prepare their reasons.

2. Reasons:
 - a. **Junior 4-H** will give two sets of reasons; one halter set and one performance set.
Senior 4-H will give four sets of reasons; two halter sets and two performance sets.
FFA Members will give three sets of reasons; one halter set and two performance sets.
 - b. Reasons will **NOT** be given on Ranch Riding.
 - c. Reasons shall be given to a judge in at a private station.
 - d. Contestants shall be notified at the appropriate time whether or not reasons will be required on the class being judged.
 - e. A reasons order will be given.
3. When four members are entered on a team, three of the highest scoring team members will make up the team total, the lowest score will be dropped. When three members are entered, all three members' scores will be tabulated. Counties are welcome to combine teams.
4. Awards will be presented following reasons.
