Once the species show begins, you will be called three times to arrive to the show ring for each of your classes. Unless a response is given with that time, you will forfeit all eligibility for that class. We will not hold classes. There will be no electricity available for beef show. Generators are permitted. We reserve the right to modify awards and premiums/payouts depending on entries in classes. Colorado State University, U.S. Department of Agriculture and Colorado counties cooperating. Extension programs are available to all without discrimination.
