 - e. Back Tags After discussing the need for back tags for the 4-H members, Linnea Frates made a motion to purchase new back tags. Riley Spurlock seconded the motion. A vote was taken, motion passed.
 - f. Ear Tags The currently supply of ear tags that the LAC has on hand at this time may not allow for everyone's tags to match due to supply chain issues beyond our control. We have an order in place that we hope will arrive in time for swine, sheep and goat weigh in/tag in date, however they may not make it on time. We will make the best of the situation as needed. A motion was made by Becky Chamblin to order 5000 new scale tickets for the scale printer. Travis Chamblin seconded the motion. A vote was taken, motion passed.
