Definitions:

Entry Deadline: *The last date for exhibit entry in EPC Fair; 4-H member indicates intent to exhibit something at the County Fair by pre-entering information into the online FairEntry system by the "Entry Deadline" in June.*

Exhibit Drop-Off: *The 4-H member/family delivers the project exhibit item(s) that have been pre-entered into the FairEntry online system to the County Fairgrounds Whittemore Building. Only those entries that have been pre-entered will be eligible for judging and exhibit.*

Exhibit Day: *The Friday before the County Fair opens to the public for 4-H members to interview and have their project exhibit judged. 4-H members will be assigned an interview time with the judge evaluating their project exhibit(s).*

Exhibitor Fee: *The initial cost to enter the El Paso County Fair in a Tabletop Project area is \$5.00 and will be added to your total FairEntry bill.*

Project/Exhibit Entry Fee: *The cost, per entry, to enter a Tabletop Project area, is \$4.00 and all entries will be added to your total FairEntry bill.*

SHOOTING SPORTS – TABLETOP EXHIBITS

In addition to participating in the El Paso County 4-H Shooting Sports County Competition, 4-H members enrolled in the Shooting Sports project are invited and encouraged to exhibit an Informational Display Board, Stand-alone or Decorative item during the El Paso County Fair.

4-H members enrolled in the Shooting Sports project, that have met all County Requirements, may participate in the El Paso County 4-H Shooting Sports Competition, enter the Shooting Sports Tabletop Exhibits, **OR BOTH.**

Please note the following rules are intended to give a basic outline of the Informational Display Board, Stand-alone and Decorative Item classes. Please refer to the [Colorado 4-H Exhibit Requirements](#) for the full class descriptions and requirements, listed at the end of this document. All entries must include a completed, discipline-specific E-Record & discipline-specific activity log. If you are planning to do a shooting sports exhibit in more than one discipline, you will need to have a separate E-record/activity log for each exhibit.

The different Shooting Sports Tabletop Exhibit areas are outlined as follows:

Informational Display Board Exhibit:

Display boards should illustrate a chosen aspect of skill areas in the specific discipline being represented. The standardized display board size of 4 ft. x 3 ft. is to be used with 4-H projects.

- No additional items may be included on or in front of the display board.
- No wooden display cases.
- No humanoid targets are allowed in any form, including within photographs or drawings.
- Do not use the word “weapon” when creating your display **or in your E-Record.**
- Make sure that there are no safety violations in your display. (Example: no earplugs, no safety glasses on a photo of a youth **holding** his/her gun.)
- Do not use pictures of firearms that are primarily tactical in design in your display, i.e., AR platform or military type firearms.
- The display board topics should stay in close relationship with your discipline. Please do not use topics outside the scope of your 4-H project. (Example: .22 Rifle Project should not use the topic of different types of military machine guns.)
- **No live ammo or projectiles including pellets, round balls, or arrows (no field/target points, broadheads, or knocks allowed), knives, functional or nonfunctional complete firearms (i.e., replica firearms, hand-made, or toy-type, etc.) or bows will be allowed as an exhibit. No actions or receivers of firearms allowed. Only 2-D cardboard or paper cutouts resembling complete firearms or bows are allowed for display purposes in the Display, Stand-Alone, and Decorative Item classes.**
 - **Functional – Any firearm or bow that can expel a projectile.**
 - **Non-Functional – Any firearm unable to expel a projectile.**
- **Projects containing any prohibited items listed in E must be judged and displayed from a photograph or a notebook of photographs and descriptions of the project and its use instead of being judged in person. Restricted physical items are prohibited from being displayed at State Fair.**
- **Members may have entries in the display board classes, the stand-alone classes, and/or decorative item class.**

Stand-Alone Exhibit:

Stand-alone items are items that are made to enhance the discipline **in which the member is enrolled**, such as a quiver, gun case, gun stand, etc. **Stand-alone items are meant to support the shooter on the range.** No display boards or decorative items are allowed in the Stand-Alone Classes. No live ammo, broadheads (ex: arrowheads), knives, functional or nonfunctional **complete** firearms or bows will be allowed to be displayed.

- **No** live ammo or projectiles including pellets, round balls, or arrows (**no field/target points, broadheads, or knocks allowed**), knives, functional or nonfunctional **complete** firearms (i.e., replica firearms, hand-made, or toy-type, etc.) or bows will be allowed as an exhibit. **No actions or receivers of firearms allowed. Only 2-D** cardboard or paper cutouts resembling **complete** firearms or bows are allowed for display purposes in the Display, Stand-Alone, and Decorative Item classes.
 - **Functional – Any firearm or bow that can expel a projectile.**
 - **Non-Functional – Any firearm unable to expel a projectile.**
- Projects containing any prohibited items listed in E must be judged and displayed from a photograph or a notebook of photographs and descriptions of the project and its use instead of being judged in person. **Restricted physical items are prohibited from being displayed at State Fair.**
- The display will be a maximum size of 3 feet wide, 3 feet deep and 7 feet in height and be stable as the item is intended for display.
- The stand-alone item should NOT exceed these dimensions when set-up in the way they are intended to be used (for example—a movable gun case must be opened on the floor to be used, and should not exceed the size limit when used this way.)
- If an exhibit is larger than this, a notebook can be used as an exhibit showing how and what was made.
- Members may have entries in the display board classes, the stand-alone classes, **and/or decorative item class.**

Decorative Item Exhibit:

Decorative items are items that provide aesthetic value as a decoration. Decorative items are items that are made from materials from the different disciplines but are only for aesthetic value in decorating a room, building, etc. **Decorative items are not meant to be used on the range. Hot glue is not recommended for gluing shells on Decorative exhibit items. Consider an epoxy or polyurethane glue.**

- Be sure to look at the classes to determine where your exhibit item fits.
- **Articles must be made that are relevant to discipline(s) in which you are enrolled**
- ALL Decorative Items, from ALL disciplines, will be judged in the Decorative Item exhibit classes.
- Decorative Exhibit items might be, but are not limited to: lamps, shelves, jewelry, artwork, etc.
- **No** live ammo or projectiles including pellets, round balls, or arrows (**no field/target points, broadheads, or knocks allowed**), knives, functional or nonfunctional **complete** firearms (i.e., replica firearms, hand-made, or toy-type, etc.) or bows will be allowed as an exhibit. **No actions or receivers of firearms allowed. Only 2-D** cardboard or paper cutouts resembling **complete** firearms or bows are allowed for display purposes in the Display, Stand-Alone, and Decorative Item classes.
 - **Functional – Any firearm or bow that can expel a projectile.**
 - **Non-Functional – Any firearm unable to expel a projectile.**
- Projects containing any prohibited items listed in E must be judged and displayed from a photograph or a notebook of photographs and descriptions of the project and its use instead of being judged in person. **Restricted physical items are prohibited from being displayed at State Fair.**
- The display will be a maximum size of 3 feet wide, 3 feet deep, 7 feet in height, and be stable as the item is intended for display.
- If an exhibit is larger than this, a notebook can be used as an exhibit showing how and what was made.

4-H SHOOTING SPORTS COUNTY COMPETITION

The El Paso 4-H Shooting Sports County Competition uses all Colorado 4-H State Shooting Sports rules. The Rulebook can be found at: <https://elpaso.extension.colostate.edu/wp-content/uploads/sites/44/2026/05/Colorado-State-4-H-Shooting-Sports-Rule-Book-2026.pdf>

Please Note: County Competition participants are divided into two age divisions:

- Junior Division – Ages 8 – 13
- Senior Division – Ages 14 – 18

4-H members enrolled in the Shooting Sports project, that have met all County Requirements, may participate in the County Competition, enter the Shooting Sports Tabletop Exhibits, **OR BOTH**.

Requirements for Participation in the El Paso County 4-H Shooting Sports County Competition are as follows:

1. Participants may compete in the 4-H Shooting Sports Discipline(s) in which they are enrolled in 4HOnline for the current 4-H year.
2. In order to be eligible to compete, participants must have two county sanctioned practices in the discipline the participant wishes to compete in.
3. .22 Pistol and Western Heritage participants must be 9 years or older and must have completed one year of range time in any other live fire 4-H program discipline before a participant will be allowed to practice and compete in .22 Pistol or the Western Heritage project with El Paso County 4-H Shooting Sports. Air pistol, air rifle, .22 rifle, shotgun or muzzleloader are considered live fire disciplines.
4. Shooting Sports Quality Assurance (SQA) is an annual safety requirement. Participants must attend an SQA to be eligible to attend the County Competition.
 - a. Eligible members may take the Online SQA, and upon receiving a 90% or Better in their age division, will have met their SQA requirement for the year. Before taking the Online SQA, please review all other Online SQA requirements and restrictions in the [El Paso County 4-H Policies for Success](#).
5. A valid Hunter's Safety Education Card is required to participate in the County Competition. This requirement is due with the completed Competition Form (found on the next pages), and paid fees, **by May 1, 2026**. If the participant does not currently have one the Colorado Department of Parks and Wildlife is the source for this certification.
 - a. Hunter's Safety Cards must be uploaded during 4-H enrollment each year, or, emailed to Jen Loewen at Jennifer.Loewen@colostate.edu and Shawna Lamothe at Shawna.Lamothe@colostate.edu by **May 1 of each year**.
 - b. For Hunter Education information go to Colorado Parks and Wildlife: <https://cpw.state.co.us/learn/Pages/HunterEducation.aspx> . Please be sure to include your Hunter Education card number with your 4-H online enrollment (if available) AND on your competition form. Competition forms without a Hunter Education number WILL NOT BE ACCEPTED.
6. Participant competition placing in each of the discipline events will be announced at the awards ceremony on **Sunday, June 28, 2026**. Members who participated in the El Paso County Shooting Sports Competition will be given an El Paso County 4-H Shooting Sports T-Shirt to be proudly worn at the El Paso County Fair, Colorado State Fair and at the Colorado State 4-H Shooting Sports Competition. (Additional T-shirts are also available for preorder only)

7. Participants will receive placing ribbons and premiums based on their placing.
8. If a participant competes at the county level and qualifies for the Colorado State 4-H Shooting Sports Competition, the participant will be notified which discipline(s) the participant qualified in.
9. If the participant chooses to participate in the Colorado State Competition, the participant will need to let El Paso County 4-H Shooting Sports know and pay fees for Colorado State 4-H Shooting Sports Competition as soon as possible.
10. If El Paso County 4-H Shooting Sports does not hear from a participant by the deadline, the next participant will be offered the Colorado State 4-H Shooting Sports Competition position.

EL PASO COUNTY 4-H SHOOTING SPORTS MARKSMANSHIP AWARD REQUIREMENTS

To compete for the Marksman of the Year Award, you must compete in 5 events across 3 disciplines and make those events in the "MARKSMAN" column of the entry form. The disciplines are identified on the entry form as: Rifle, Pistol, Muzzleloader, Archery, and Shotgun. An example of an eligible group of events would be 3 rifle events, 1 pistol event, and 1 muzzleloader event. An ineligible entry would be any entry with either 4 rifle events or 3 events in one discipline (rifle or shotgun) and 2 events in a second discipline (rifle, pistol, muzzleloader, or shotgun).

Scores are calculated by totaling the shooter's final scores across the declared contests, except the scores will be modified to a maximum of 200 per event, or 1,000 total. Each events have a maximum potential score and a multiplier as follows:

50 points:	Shotgun (All events)	Multiplier = x4
150 points:	Muzzleloader (All events), Rifle (3P Air)	Multiplier = x1 ^{1/3}
200 points:	Rifle (Air Utility, Air 4P, and Air Off Hand), Pistol (Air), and Junior Archery (All events)	Multiplier = x1
300 points:	Rifle (.22 3P)	Multiplier = x ^{2/3}
400 points:	Rifle (.22 Open, .22 Scope, and .22 4P), Senior Archery (all events)	Multiplier = x ^{1/2}
600 points:	Pistol (.22)	Multiplier = x ^{1/3}

It's important to pick your events not on how high of a score you can get but how close to the maximum you are. For example, a great .22 Pistol score of 330 is equivalent to an Air Pistol score of 110. Remember to keep records of your scores throughout the year to determine which events you're truly a marksman in (you'll also need them for your e-record book).

The EPC 4-H Shooting Sports Advisory Committee will nominate members based on member's attitude and positive Sportsmanship behavior during the current 4-H year. Awards are dependent on funding – up to two Sportsmanship Awards can be offered each year. Members will receive recognition at the Annual 4-H Achievement Awards Ceremony.

EL PASO COUNTY 4-H SHOOTING SPORTS MOST IMPROVED AWARD REQUIREMENTS

Award Requirements/Description: Member must be an active, enrolled member in El Paso County 4-H, enrolled in a 4-H Shooting Sports Discipline. The EPC 4-H Shooting Sports Advisory Committee will nominate members based on a member's attitude and overall improvement during the current 4-H Year. Awards are dependent on funding – up to two Most Improved Awards can be offered each year. Members will receive recognition at the Annual 4-H Achievement Awards Ceremony.

If you would like to compete at the state level in any event you might qualify for, please indicate which events by marking the "STATE" column on the entry form. Please double check your calendar to make sure you won't be otherwise occupied. Only 6 kids may compete in any event for our county in all events except Shotgun which is limited to 5. If you know that you will absolutely not be able to compete at state, letting us know by not checking the state column could potentially open the spot for another eligible shooter. Muzzleloader Pistol is the only event you cannot compete at the state level as the state does not host an event for it.

What's the importance of State Competition? For Seniors it's your opportunity to win a shot at going to the National 4-H Competition. Only four shooters can represent our state per discipline each year, so being one of those four is a tremendous honor and often a once in a lifetime opportunity. For Juniors, it's your opportunity to experience one of the largest youth shooting events around. You can meet new friends with similar interests or skills and experience a new form of friendly competition or simply hone your shooting skills. Juniors are not eligible for Nationals, but that's no reason to avoid going to the State Competition.

Note: Please read 4-H Project Exhibit Rules on pages 3 and 4.

Project Exhibit Rules:

- A. There is one e-Record that contains the inventory sheet and the discipline-specific activity log records for all the disciplines that are required for this project.
- B. Be sure to include the activity log for the discipline that you are exhibiting in your record book. If you are planning to do a shooting sports exhibit in more than one discipline at the county or state fair, you will need to have a separate e-record for each exhibit with the discipline specific activity log.
- C. Display should illustrate a chosen aspect of skill areas. This is separate from the Colorado State 4-H Shooting Sports Championships. (The standardized display board size of 4 ft. x 3 ft. is to be used with 4-H projects. No additional items may be included on or in front of the display board.) No wooden display cases. No humanoid targets are allowed in any form, including within photographs or drawings.
- D. Counties may enter only one exhibit per class. Members may have entries in both the display board classes and the stand-alone classes.
- E. **No live ammo or projectiles including pellets, round balls, or arrows (no field/target points, broadheads, or knocks allowed), knives, functional or nonfunctional complete firearms (i.e., replica firearms, hand-made, or toy-type, etc.) or bows will be allowed as an exhibit. No actions or receivers of firearms allowed. Only 2-D cardboard or paper cutouts resembling complete firearms or bows are allowed for display purposes in the Display, Stand-Alone, and Decorative Item classes.**
 - a. **Functional – Any firearm or bow that can expel a projectile.**
 - b. **Non-Functional – Any firearm unable to expel a projectile.**
- F. **Projects containing any prohibited items listed in E must be judged and displayed from a photograph or a notebook of photographs and descriptions of the project and its use instead of being judged in person. Restricted physical items are prohibited from being displayed at State Fair.**
- G. Do not use the word weapon when creating your display. Make sure that there are no safety violations in your display. (Example: no earplugs, no safety glasses on a photo of a youth holding his/her gun.) Do not use pictures of firearms that are primarily tactical in design in your display, i.e., AR platform or military type firearms.
- H. Historic photos or artist depictions used in exhibits that are not displaying current 4-H practices must have the following disclaimer posted with them, "These are historic photographs and artist renderings. Therefore, they do not follow modern safety protocols for Colorado 4-H."
- I. The display board topics should stay in close relationship with your discipline. Please do not use topics outside the scope of your 4-H project. (Example: .22 Rifle Project should not use the topic of different types of military machine guns.)
- J. Stand-alone items are items that are made to enhance the discipline, such as a quiver, gun case, gun stand, etc. No display boards or decorative items are allowed in the Stand-Alone Classes.
- K. All items in the Stand-Alone and Decorative Item classes will be a maximum size of 3 feet wide, 3 feet deep and 7 feet in height as the item is intended for display. The item must be stable when standing to be displayed within the 3' x 3' space. If an exhibit is larger than this, a notebook can be used as an exhibit showing how and what was made.
- L. For those members who are exhibiting both a display board and a stand-alone, they may copy their e-Record. Each exhibit must have an e-Record. Be sure to highlight what you are exhibiting in your e-Record.
- M. No stand-alone items that are an exhibit at the time of the contests will be allowed to be removed from the building to be used at the contests.
- N. **Items to be exhibited in the Decorative Item class are items that are used as a decoration and must relate to the discipline(s) in which the member is enrolled. Be sure to look at the classes to determine where your exhibit item fits.** If you have questions about your display or requirements, contact your county Extension 4-H Specialist/Coordinator.

All exhibits will consist of the following (see E above for prohibited items):

- A. Completed e-Record for the discipline exhibited to be presented in a sturdy binder/notebook. The e-Record needs to contain the activity log sheet for the discipline being exhibited. The e-Record containing all log sheets can be found at <https://co4h.colostate.edu/4h-project/4-h-shooting-sports-project/>. Items in the

Decorative Item class must include the Decorative Item Page in the e-Record and a photo of the exhibit must be included on the Photo page(s).

B. **Display Board Exhibits:** One display board illustrating something learned in the project this year. The standardized display board size of 4 ft. x 3 ft. is to be used with 4-H projects. No additional items may be included in front of the display board.

For Stand-Alone Exhibits: One article which you have made as a part of the project this year.

(Examples: gunstocks, gun racks, decoys, quivers, but not limited to just these.) **No** live ammo or projectiles including pellets, round balls, or arrows (with or without field points, broadheads, or knocks), knives, functional or nonfunctional firearms or bows will be allowed as an exhibit. The display will be a maximum size of 3 feet wide, 3 feet deep and 7 feet in height and be stable as the item is intended for display.

For Decorative Exhibit Items: One article which you have made as a part of the discipline(s) in which you are enrolled this year. This item would be considered a decorative item (lamps, shelves, jewelry, artwork, etc.). The display will be a maximum size of 3 feet wide, 3 feet deep, 7 feet in height, and be stable as the item is intended for display.
